The City of Brawley is requesting Statements of Interest and Qualifications (SOQs) for the **AIRPORT MANAGER/FIXED BASE OPERATOR** at the Brawley Municipal Airport.

SEALED PROPOSALS will be received by Ana Gutierrez, Public Works Analyst at 180 South Western Avenue, Brawley, California 92227 until **2:00 P.M.**, local time on **February 27, 2024**.

All proposals shall be submitted in a sealed envelope with the proposer's name and address on the outside of the envelope and marked: "PROPOSAL: "PROPOSAL" AIRPORT MANAGER/FIXED BASE OPERATOR(FBO).

In addition to the included duties, a service scope detail will be added in the lease agreement which reserves the right of the City to maintain and keep in repair all publicly owned facilities at the airport and to direct and control the activities of the FBO.

However, all proposers will be held accountable for any information and instructions that are given at the Pre-Proposal Conference.
